

## ***The Deadly Dangers of Mercury with Electromagnetic Fields...*** ***....Experienced and written by Debbie Bevel...***

As a child, I had 'silver' (mercury) amalgam fillings placed in all of my molars. I always thought these fillings were just *silver* until I read the truth about them later – that they contain mercury. I had always been told by my dentists that these amalgam fillings were perfectly safe. I had all of my vaccinations. I was never told and never knew that mercury was commonly used in vaccines.

In the year 1997, when a molar on my upper left jaw became painful, dentist #1 told me he was going to shave off a little of the old filling and place another filling next to it before placing a crown on top. He assured me the filling and crown would last the rest of my life.

I may have swallowed some mercury particles because soon after this crown was placed, I became very weak. I developed a terrible cough that prescription medications could not stop for several years. I developed heart arrhythmias, tachycardia, palpitations, severe cold chills, and insomnia. I began to have tremors, panic attacks, and loss of balance. I had a vaccination during this time. I lost my appetite and had constant fatigue. My eyesight deteriorated rapidly. Both of my eyes started going to the left. I had a lot of floaters in my eyes and double-vision. My ophthalmologist noticed this as well. I became sensitive to light and sound. I started using a cell phone for work. I had better reception on my left side. I would get severe headaches - especially when I wasn't taking strong antibiotics. I was prescribed a lot of medications for all my symptoms.

By the year 2001, I felt severely burned on the inside of my head and it would hurt everything in my head to breathe in through my nose with my mouth closed. I knew I wouldn't live much longer if someone didn't help me soon!!

**I prayed for my life!!** Then I remembered all my amalgam fillings. I recalled reading in the past that **MERCURY** was in amalgam and in some vaccinations and that heat vaporizes mercury into methyl-mercury!

I went to see dentist #2 and told him I felt I had been poisoned and burned by the mercury vapors from my mercury amalgam fillings. He asked me what I meant by *poisoned*. I told him, "You know - Toxic". He didn't know what to say. I told him I wanted an x-ray taken.

His assistant took a panorex x-ray of my teeth. It turned out totally black. They did it again to make sure the settings were correct on the x-ray machine. The second one turned out totally black as well. No one before or after me has ever had black panorex x-rays with this x-ray machine. To the right is one of those x-rays.



The dental assistants told me when he wasn't in the room that dentists cannot tell their patients that mercury amalgam is toxic because some have lost their license for telling their patients this.

I needed help quickly. I was referred to dentist #3. He knows the biocompatibility of metal dental materials and how they can affect the body. He is also an oral surgeon and spends a lot of his time cleaning jaw cavitations.

Dentist# 3 noticed I had mercury in a few places in my jaws. I had him remove the crown on my upper left jaw after I remembered mercury was underneath it. The crown had a dissimilar metal base next to the mercury underneath it. This dissimilar mixture of materials made the mercury much more toxic. He

showed me where only half the tooth was left after the mercury amalgam was removed and where half the tooth behind it – on the side - had busted off...

I had three places in my jaws that were very painful. I had him clean these cavitations. One was under a root canal tooth. I had him pull this tooth. There was some type of metal in the root. Biopsies on my left jaws were *ischemic osteoporosis with desiccated tissue and no sign of malignancy*. The severe pain in my jaws went away after these surgeries.

The doctor who saved my life is Dr. Ji-Zhou (Joseph) Kang, H.M.D. I bet there is no other doctor like him in the world. He has degrees and awards from all over the world. He was awarded in 1995, the *Twentieth Century Achievement Award*, honoring him as the "*Top of the 500 Most Influential Leaders of the Twentieth Century*". If Dr. Kang had not been there to help me, and I had not been fortunate enough to see him, I would have died in the year 2001. Dr. Kang is now 77 years old and is retiring. I'm afraid the next person who is hurt like I was won't be able to get the help that I did.
